

# ADDITION OF TWO NEW DUGOUT ROOFS


Palmer Ball Association

**AMOUNT:** \$1,222


FUND: Washington County Opportunity Fund

# Beginning of a Food Bank in Clifton

**AMOUNT:** \$1,000

FUND: Washington County Opportunity Fund

This past year, the Lucky-4 4-H Club, Beautification Committee of Clifton, and the Presbyterian Church teamed up to start a food bank in Clifton, KS, behind the Clifton Presbyterian Church. This location was the perfect spot due to the church having a driveway around the back that would provide a safe location for community members to pull up and grab needed food out of the food pantry. The church also offers a great location for the public to easily make and store donations.

Through a \$1,000 grant from the Washington County Community Foundation, much needed food and hygiene items were purchased to get the food bank initially started and running.

The grant funding received has provided the town of Clifton and the surrounding areas to have an opportunity to get some sort of assistance with food and hygiene products privately and safely. With the previous closest food bank being 10-30 miles away, it has also provided convenience to local families by making it possible for them to cut travel time.



### Tails and Tales at Clifton Public Library

**AMOUNT:** \$300

FUND: Buckshot & Christine Buchanan Donor Advised Fund

During the summer the Clifton Library sponsors a summer reading program with one story time a week for infants up to six years old, and another story time for ages over six. Arts and crafts are done at each session of story times.

Thanks to a grant from the foundation, books were able to be purchased to gift as a reward to kids for accomplishing their summer reading. The summer reading program was a success, and along with 28 books being given away, there were 148 kids who attended throughout the summer for story time.

### Chromebook Purchases for Grades 1-2

AMOUNT: \$1,008.58

FUND: Washington County Opportunity Fund/Hanover Community Fund


Thanks to a grant from the Washington County Community Foundation, St. John's School was able to purchase new Chromebooks for their students, allowing students in their earlier years to be more familiar with them and be able to transition easily into using them independently as they progress through their education.

"This project was needed, but we had no idea how timely it would be. The purchase of these Chromebooks allowed us to have devices we could provide to our students during COVID," said grantee Amanda Cook.

### COMMUNITY IMPACT BY CATEGORY

Each year, the WCCF Advisory Board accepts grant applications through a competitive process and is entrusted to award grants based upon a set of criteria to meet the needs of our community. Since inception, the Board has awarded more than \$95,000 through its competitive grant process.

#### COMMUNITY DEVELOPMENT

### Linn Lutheran School Playground Improvement

**AMOUNT:** \$1,984

FUND: Kansas Health Foundation for Washington County

Linn Lutheran School in Linn has been around as a school since 1887. When a building project caused part of the playground equipment to be retired, it was time to upgrade and replace some equipment. The school playground is used frequently during the school day and in the evening by members of the community.

With the support of the parent teacher organization and the Washington County Community Foundation grant, Linn Lutheran was able to purchase a "super climbing dome", and with the help of many volunteers, add it to the new playground area. Students and community children can practice their climbing skills and enjoy a wide variety of physical activities.

"The super climbing dome has added to the variety of skills our playground showcases. Students can practice climbing in a safe environment and can really develop good hand-eye coordination," said David Beikmann, principal of Linn Lutheran.

### Haddam City Hall Project

**AMOUNT: \$1,698** 

FUND: Washington County Opportunity Fund

Haddam Community Club, Inc., requested grant funding to continue the improvements on the 1912 Haddam City Hall/Community Center, focusing specifically on the windows. Seven new windows were purchased and installed during this improvement project to replace the broken, unsightly, energy consuming windows that were previously there.






#### MATCH MADNESS SUCCESS
